



## East Lothian and Midlothian Public Protection Training Calendar 2022

The calendar for Public Protection Training is overleaf. This is updated on a quarterly basis, so please look out for any new courses coming onto the calendar.

If you wish to attend a course, you should first speak to your line manager about whether this course is suitable for your role and level of experience. Before applying for any course, you are required to seek your manager's approval, ensure that you are available on the day and have protected time to attend before applying. There may also be pre-requisites for attending courses.

After you have attended any training event, you are required to inform your own workforce development team/section for their own training records.

All courses apart from those below are booked via the East Lothian and Midlothian Public Protection Office. Details of each course and the application form are included in the course flyer, which will be sent out to agency contacts and will be circulated by your own agency.

Places on some courses will be offered on a first come, first served basis, and others will be arranged according to individual need and priority, which will be agreed with your organisation.

**Child Protection (Multi-Agency Level 1) in East Lothian** courses are NOT booked through the EMPPO.
